

- 3. Acting as a nodal agency of the Institution for coordinating quality-related activities, including adoption and dissemination of best practices.


- 4. Development and maintenance of institutional database through MIS for the purpose of maintaining/enhancing the institutional quality.

- 11. Documentation of the various programmers/ activities leading to quality improvement.


Mechanism of functioning:


- 1. University Criteria Conveners, co-conveners have been appointed by the IQAC for the seven NAAC criteria.
- 2. Conveners and co conveners are assisted by college conveners from each constituent faculty of KIMSDU.
- 3. Inputs from conveners and members of seven autonomous cells helps in enriching the data collected by IQAC.
- 4. Dean Academics have been entrusted with the task of assisting and monitoring data collection and record maintenance of the concern faculty. They scrutinize all the documents before submitting it to Director IQAC.
- 5. The IQAC Director will be the custodian of all documents and records.
 - KIMSDU IQAC meeting will be held atleast once in every quarter of the academic year. The quorum for the meeting shall be two-third of the total number of members. The agenda, minutes and action taken reports are documented with official signatures and maintained electronically in a retrievable format. The head of the institution may call for an urgent meeting whenever necessary.
 - The IQAC will prepare an annual calendar of events and implement the same after the approval of the Board of Management .All members actively participate in the events organized by IQAC.

- IQAC prepared Annual Quality Assurance Report (AQAR) for the academic year (1st July to 30th June) every year and submit the same to NAAC after approval of the Board of Management.
- In view of preparation for second cycle of accreditation by NAAC IQAC has established steering committee for the preparation of SSR and developed tools to assess and monitor the progress of work for self-study report and these **tools are copyrighted**.
